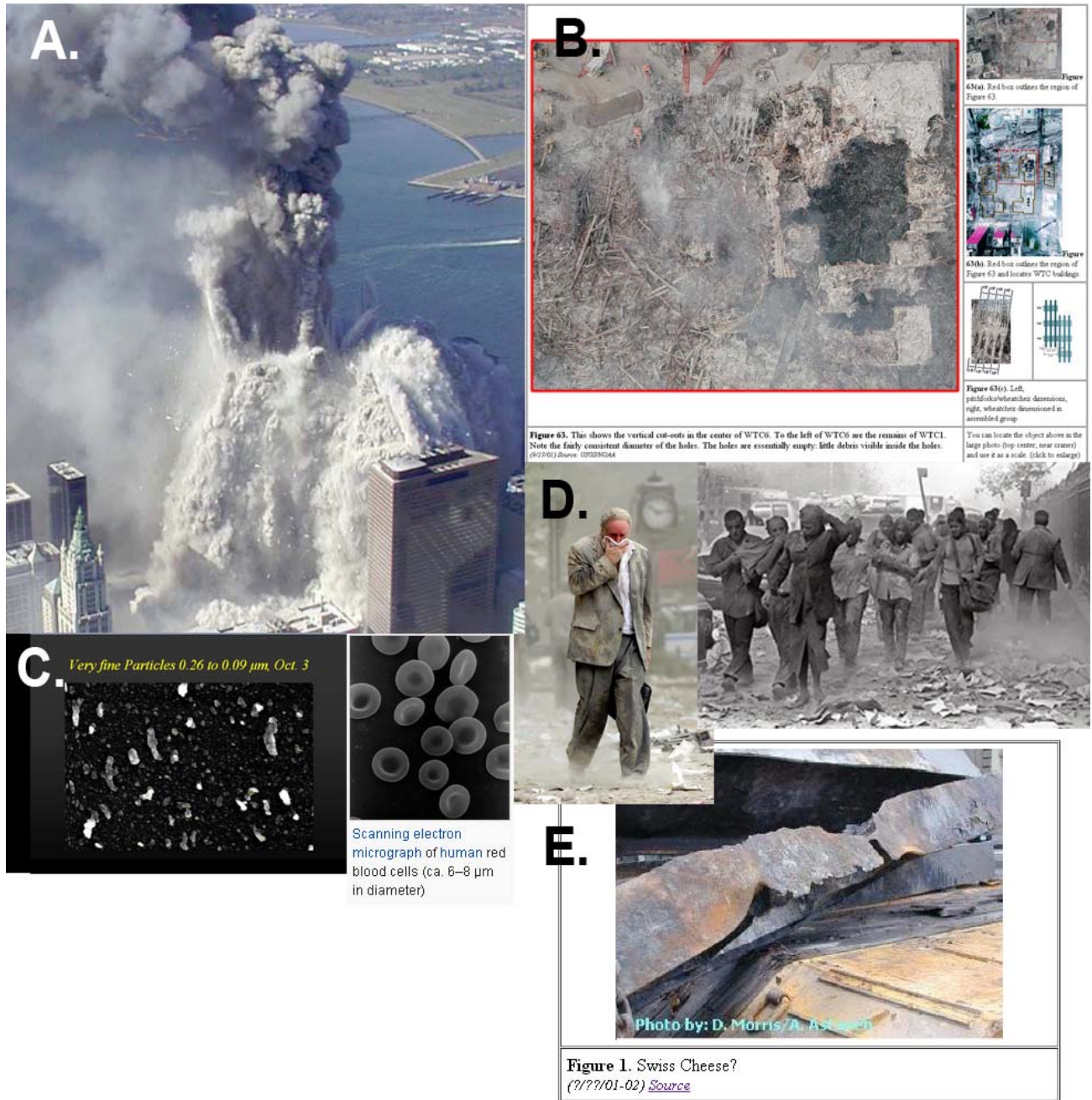


# Reference



The evidence below is but a minute portion of the forensic evidence compiled by Dr. Judy Wood concerning the 9/11 tragedy. Dr. Wood, formerly a member of the faculty at Clemson University, holds a B.S. in Civil Engineering, a M.S. in

Engineering Mechanics (Applied Physics), and a Ph.D. in Materials Engineering Science.

Dr. Wood and Dr. Morgan Reynolds (Emeritus, Texas A & M University) first “challenged” the National Institute

of Standards and Technology (NIST), official U.S. government report (Sept 2005) on the 9/11 disaster in a "Request for Correction" (Mar 2007). Later, in two "Qui Tam" cases (June 2008 and Oct 2009), Dr. Wood established the forensic evidence that the NIST study of the WTC collapse was fraudulent and deceptive. 28. You've coined the term "dustification" to describe what happened to the towers. Can you define this?

The buildings were turned to dust. The exact mechanism is not known, but it is known that there was such a process. The term, dustification, is given to refer to this, yet-to-be-defined, mechanism. Dustification means that the buildings were not melted, evaporated, or turned to coarse rubble. It is a known fact that the contents of the Twin Towers were converted to very fine dust that covered much of lower Manhattan several inches deep. It can be seen as the buildings came down that the mass above the demolition wave is no longer there, is not falling past the demolition wave and is not in its original condition. Where did it go? All that is left is a giant cloud of dust that moves with great force throughout downtown Manhattan and drifts away with the wind. 18. If not, why should we take you seriously?

As noted previously, the visual evidence provides the best description of what happened. Look at all of the various anomalies pointed about by the research shown (Go to: [E. Here are the principal data that must be explained](#)). Note that all anomalies can be explained by this mechanism.

The fact that other theories have already been debunked by NIST (thermite/thermate, bombs-in-the-building) and the fact that it is a physical impossibility that the buildings turned to dust on their own through fire-induced collapse, some source of energy was utilized. The vertical holes in WTC 5 & WTC 6 are very incriminating. No debris is found in the holes and they are perfectly vertical like the Etch-A-Sketch lines drawn on the famous children's toy. Something removed this material in (approximately) 24 foot swaths. Something broke down the steel, concrete, and other building materials in the Twin Towers symmetrically and at freefall speed in a vacuum. "In any case, what we are looking at in these pictures, graphs, and analyses is evidence of the almost total pulverization, right down to 'molecular dissociation,' the coming apart of molecules. This molecularly-

dissociated dust has to have been the result of another mechanism of destruction than one caused by burning fuel or controlled demolition, for those mechanisms cannot bring about molecular dissociation and the almost complete dustification of a building. Molecular dissociation occurs with ionization and is seen in cold fusion. A group of researchers also determined that electric field fluctuations in liquid water cause molecular dissociation.”

Evidence of molecular dissociation (DEW) is shown in the figures below. I understand the FEMA report to say these came from WTC7. I also have a nice FEMA picture showing the half dissolved beam by that hole in Liberty Street (last figure).

“DELTA group noted that there were two very different types of air pollution from the 9/11/01 event.

The collapse of the World Trade Center structures (South Tower, North Tower, and WTC 7) presented two very different types of air pollution events:

1. Initial fires and collapse-derived ‘dust storm’
2. Continuing emissions from the debris piles

Both cases shared the unusual aspect of a massive ground level source of particulate matter in a highly populated area with potential health impacts.”

“There have been no studies of ‘continuing emissions’ resulting from a

normal building collapse or from a normal controlled demolition. Ongoing fires can emit pollutants into the air, but according to Dr. Thomas Cahill, the DELTA group had never recorded such high levels as this in ‘over 7,000 measurements [studies] [they] have made of very fine air pollution throughout the world...’ The image in Figure 341 shows visible fuming from the truck bed in March 2002. Some fuming was still visible when I, along with others, visited the site in October 2007 and in January 2008 and photographed the fuming. Some of the photographs are available on my website.”

"Materials science professors Ronald R. Biederman and Richard D. Sisson Jr. confirmed the presence of eutectic formations by examining steel samples under optical and scanning electron microscopes. A preliminary report was

published in JOM, the journal of the Minerals, Metals & Materials Society. A more detailed analysis comprises Appendix C of the FEMA report. The New York Times called these findings "perhaps the deepest mystery uncovered in the investigation." The significance of the work on a sample from Building 7 and a structural column from one of the twin towers becomes apparent only when one sees these heavy chunks of damaged metal."
